



A short checklist to prepare for Department of Labour and Employment Inspections During Lockdown

Please note that visits can ONLY be made by appointment and in accordance with the On Farm Protocol. The Department will also have to adhere to all guidelines regarding COVID-19.

Specific aspects that inspectors look at are:

- Availability of hand-washing facilities and hand sanitizers with at least 60% alcohol content?
- Are there reminders of good hygiene placed in the workplace?
- Is Covid-19 part of the employer's risk assessment?
- Is a distance of at least 1 m being maintained between workers in the workplace?
- Is training being provided to workers on COVID-19 and records of such training are kept?
- Evidence that the farm health & safety committee meet regularly on the pandemic and that they sign off on sessions?
- Transport of workers:
 - Are there markers on the floor of vehicles where people have to sit / stand to maintain adequate social distance?
 - Is the vehicle's licensed carrying capacity being adhered to?
 - Are transport permits in place for each individual driver?
 - Are drivers wearing masks?

Spesifieke aspekte waaraan aandag gegee moet word:

- Beskikbaarheid van handwas-geriewe en handsaniteerdeer met 'n minimum alkoholvlak van 60%.
- Is daar aanmanings oor goeie higiëne in die werkplek opgesit?
- Is Covid-19 deel van die werkgewer se risiko-assessering?
- Is daar 'n afstand van minstens 1 meter wat tussen werkers in die werkplek gehadhaaf word?
- Word opleiding oor COVID-19 aan werkers voorsien en word daar rekord gehou van die opleiding?
- Is daar bewyse dat die plaas se gesondheid-en veiligheidskomitee gereeld vergader oor die pandemie en is daar bewys van bywoning van hierdie sessies?
- Vervoer van werkers:
 - Is daar merkers op die vloere van vervoerruimtes vir werkers om te sit of staan om voldoende afstand te handhaaf?
 - Word voertuie se gelisensieerde drakrag gehandhaaf? ?
 - Is daar toepaslike vervoerpermitte in plek vir elke bestuurder?
 - Dra voertuigbestuurders maskers?
