ERRATUM NOTICE

DRAFT AMENDMENTS MADE IN TERMS OF THE PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001 (ACT NO. 56 OF 2001)

Please note that the **Draft Amendment Regulations** in terms of the Private Security Industry Regulation Act, 2001 (Act No.56 of 2001) relating to Uniforms, Insignia and Badges, and **Draft Amendments to the Code of Conduct** made under the Private Security Industry Regulation Act, 2001 (Act No.56 of 2001) relating to security service providers ensuring order and safety on premises used for sporting, recreational, entertainment or similar purposes, which were published on 03 July 2020 under Notice 362 of 2020 contain an **error**.

The two Draft Amendment Regulations were initially published on 31 May 2019 under Notice 292 of 2019 and Notice 294 of 2019 for public participation. The publication of the Draft Amendment Regulations was followed by Consultations, in which the public, members of the private security industry and all other interested parties were able to make submissions. The Private Security Industry Regulatory Authority (PSiRA) considered the submissions made and conceded to some of the submissions. Thereafter, the Authority submitted the Draft Amendments Regulations (as the **Final Amendment Regulations**) to the office of the Minister of Police for concurrence and promulgation.

The Uniforms, Insignia and Badges Regulations were signed on 27 March 2020 and the Regulations dealing with security service providers ensuring order and safety on premises used for sporting, recreational, entertainment or similar purposes regulations were signed on 01 April 2020 by the Minister of Police, for promulgation. Consequently, the Regulations comes into operation on the date published in the *Gazette*, which was on 03 July 2020.

Therefore, the following errors are hereby corrected as follows:
